Healthcare Program. Since 2008, Muso has partnered with the Malian Ministry of Health to design and test a model health care system that improves child survival and ensures quality health care for all community members. We designed a health system to deliver life saving-tools to prevent and cure disease quickly and efficiently to everyone who needs them. Our model systematically removes financial, informational, infrastructural, and geographic barriers to health care. We employ three key strategies: (1) Community Health Workers, who conduct door-to-door home visits, actively search for sick community members. They provide prevention counseling, diagnosis, and treatment of simple disease, and refer or accompany patients to the health center as needed. (2) Health care financing reform removes fees for those who cannot afford to pay. (3) Clinical capacity building through construction of clinical facilities and training of medical providers. We employ these three strategies to reach patients early, and to connect each of Yirimadjo's more than 56,000 citizens with quality health care.

The Non-Formal Education Program has been empowering participants to become leaders who work to improve the health and well-being of their families and their communities. Classes are taught in the local language by community members who received intensive training in the course material. Education centers are strategically located throughout Yirimadjo to ensure accessibility to all students, whether they are a busy mother of eight, a local mechanic, or an adolescent girl. Starting in 2009, Muso began a partnership with Tostan to implement Mali's first ever pilot of Tostan's award winning curriculum.

Springboard Microfinance Program. Our program fills this critical financial access gap to enable women living in poverty to successfully enter the marketplace.
